Chairman Sanders called the meeting to order at 5:30 PM

Mrs. Johnson, Clerk of Courts, stated that the millage rate for the proposed budget is 30.00% over the rolled-back rate which is 3.1158 mills and the advertised millage rate is 4.0504 and the advertised total budget amount is \$34,036,313.00 for the 2005-2006 Budget. Mrs. Johnson also stated that the total certified taxable value of real estate for budget purposes is \$3,360,049,261.00 and one mill will generate \$3,360,049.00.

Chairman Sanders opened the floor for public comments; there were no comments from the floor.

Ms Johnson read the following resolution, for approval, to adopt the Millage Levy:

WHEREAS, the BOARD OF COUNTY COMMISSIONERS of Franklin County, Florida, on September 26, 2005, adopted Fiscal Year 2005/2006 Final Millage Rates following a public hearing as required by Florida Statute 200.065; and

WHEREAS, the BOARD OF COUNTY COMMISSIONERS of Franklin County, Florida, held a public hearing as required by Florida Statute 200.065; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Franklin County has been certified by the County Property Appraiser to the BOARD OF COUNTY COMMISSIONERS as \$3,360,049,261.00

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COUNTY COMMISSIONERS of Franklin County, Florida that:

- 1. The Fiscal Year 2005/2006 operating millage rate for Countywide is **4.0504** mills which is greater than the rolled-back rate of **3.1158** mills by **30.00%**.
- 2. This resolution shall take effect immediately upon its adoption.
