

FCBCC SPECIAL MEETING NOVEMBER 19, 2004

FRANKLIN COUNTY BOARD OF COUNTY COMMISSIONERS
SPECIAL MEETING
NOVEMBER 19, 2004

OFFICIAL IN ATTENDANCE: Cheryl Sanders, Chairman, Commissioners Jimmy Mosconis, Bevin Putnal, Noah Lockley, Jr., Russell Crofton, Michael Shuler, County Attorney.

9:00 A.M.: Chairman Sanders called the meeting to order. She told the audience this special meeting was called to review applications for the Director of Administrative Services/County Planner for the County.

(Tape 1-16) Michael Shuler, County, stated that several weeks ago the Board had directed him to advertise for the position of County Planner and Director of Administrative Services. This meeting is being held to open those Requests for Proposal. Commissioner Putnal entered the meeting.

Mr. Shuler told the Board that there has been one submittal for the position. It was submitted on November 16, 2004 at 2:20 P.M. initialed by Amelia Varnes.

(Tape 1-64) Commissioner Crofton said he feels the process has been flawed. He went on to say there is nothing against Alan Pierce, he feels that it is the process that is flawed. He feels that the County should have advertised in the larger newspapers in Florida.

Mr. Shuler said that it is certainly at the Board discretion as to how to advertise, however, the county has always advertised locally for its positions. The advertisement was done as all other advertisements have been done.

Chairman Sanders asked if there are any guidelines setup by Florida Statute concerning advertising for positions.

Commissioner Crofton said that he has had people tell him that it was not broadly advertised. He would like to readvertise in larger newspapers such as Miami News Herald, Jacksonville, Tallahassee and Panama City.

Commissioner Mosconis asked Mr. Shuler if this advertisement had run longer than is required. Mr. Shuler stated that the advertisement has been run the same as any other position offered in the County.

(Tape 1-197) Commissioner Crofton made a **motion to table this review and readvertise the position for Director of Administrative Services/County Planner in several large newspapers in Florida.** Commissioner Lockley seconded the motion. Commissioners Putnal, Lockley, Crofton and Chairman Sanders voted for. Commissioner Mosconis voted against.

After the motion, it was agreed to rescan the RFP received from Alan Pierce and give to Marica Johnson, Clerk-Elect, for safe keeping until the December 21st meeting.

Mr. Pierce tries to get clarification of Board as to whether to continue with his services(?).


Special meeting set for 1:00 P.M., December 21, 2004, to open RFPs.
