**MINUTES**

**Commissioners Present:** William Massey – Chairman, Joseph Parrish – Vice Chairman, Noah Lockley, Cheryl Sanders, District 1 Commission Seat- Vacant pending appointment.

**Others Present:** Michael Moron-County Coordinator, Linda Phillips-Finance Officer, Erin Griffith- Assistant Finance Officer, Lauren Luberto-Finance Clerk, Lori Hines-Deputy Clerk to the Board.

**Call to Order**

Chairman Massey called the meeting to Order.

Mrs. Erin Griffith, Assistant Finance Officer, said this is the Public Hearing to adopt the final budget for fiscal year 2015-16. She explained at this meeting the Board must adopt the final budget and final millage rate for fiscal year 2015-16. Mrs. Griffith reported it will take 6.3065 mills to fund this budget and the total tentative budget is \$44,106,428. She said the tentative millage rate of 6.3065 mills is equal to the roll back rate of 6.3065 mills.

Chairman Massey asked for public comments. There were no public comments.

Mrs. Griffith read the Resolution Adopting the Millage Levy. On motion by Commissioner Sanders, seconded by Commissioner Lockley, and by unanimous vote of the Board present, it was agreed to adopt the Resolution Adopting the Millage Levy, as follows:

**FRANKLIN COUNTY, FLORIDA, ADOPTING THE FINAL LEVYING OF AD VALOREM TAXES FOR FRANKLIN COUNTY FOR FISCAL YEAR 2015/2016; PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the BOARD OF COUNTY COMMISSIONERS of Franklin County, Florida, on September 21st, 2015, adopted Fiscal Year 2015-2016 Final Millage Rate following a public hearing as required by Florida Statute 200.065; and

**WHEREAS**, the gross taxable value for operating purposes not exempt from taxation within Franklin County has been certified by the County Property Appraiser to the BOARD OF COUNTY COMMISSIONERS as \$1,690,427,690.

**NOW, THEREFORE, BE IT RESOLVED** by the BOARD OF COUNTY COMMISSIONERS of Franklin County, Florida that:

1. The Fiscal Year 2015/2016 operating millage rate for Franklin County is **6.3065** mills which is equal to the rolled-back rate of **6.3065** mills.
2. This resolution shall take effect immediately upon its adoption.
